INSTRUCTIONS: Please read this entire agreement carefully. This Agreement, in addition to the Rights and Restrictions and the Charlottesville Stock Photography Terms and Conditions, constitutes the binding contract with respect to your obtaining the right to use stock photographic and other media content (the "Licensed Content") available through the Charlottesville Stock Photography Collection of the website located at www.charlottesvillestockphotography.com (the "Website"). This is a legal agreement between you ("Licensee") and Charlottesville Stock Photography, LLC. ("Charlottesville Stock Photography"), operator of the Website. The terms of this Agreement shall govern any inconsistency between this Agreement, the Terms and Conditions, or the Content Contributor Agreement on the Website. Regardless of whether this form is deemed an offer, acceptance or a confirmation, Charlottesville Stock Photography expressly conditions the license granted herein on Licensee's agreement to this Agreement. This Agreement becomes effective upon your purchase of a license through the Website and remains in full force and effect until terminated in accordance with its terms. If you are accepting on behalf of an entity (other than yourself as an individual) you represent and warrant that you have full legal authority to bind your employer or such other entity. If such entity disputes your power and authority to act on its behalf with respect to this Agreement, you shall be bound and liable for any failure by you to comply with the terms of this Agreement, and shall be obligated to make payment to Charlottesville Stock Photography for the Content you license hereunder.

1. DEFINITIONS

Capitalized terms not defined here shall have the meaning set forth in the Charlottesville Stock Photography Terms and Conditions or the Charlottesville Stock Photography Content Contributor Agreement.

a. "Editorial Licensed Content" means Licensed Content relating to events that are newsworthy or of public interest and that are licensed for use in an editorial manner.

b. "Invoice" means the computer-generated or pre-printed invoice provided by Charlottesville Stock Photography that (i) specifies the license is rights-managed, (ii) sets forth, without limitation, the specific party contributing the Licensed Content, the specific areas of use for the Licensed Content selected and the limitations on the license (if any), (iii) states the corresponding price(s) for the license of such Licensed Content, and (iv) incorporates this Agreement and the Charlottesville Stock Photography Terms and Conditions. All references to the "Agreement" include the Invoice.

c. "Licensed Content" means any still image, illustration, animation, Flash file or other

material including any negatives, transparencies, film imprints, prints, original digital files or any reproductions thereof, or any other product protected by copyright, trademark, patent or other intellectual property rights, which is licensed to Licensee under the terms of this Agreement.

d. "Permitted Use" means:

- . for rights-managed Licensed Content: solely the use, medium, period of time, print run, placement, size, territory and other restrictions, if any, as specified in the Rights and Restrictions.
- . additionally, for rights-managed Editorial Licensed Content: use solely in an editorial manner, in relation to events that are newsworthy or of public interest, and unless additional rights are stipulated in the Rights and Restrictions or granted pursuant to a separate license agreement, not for any commercial, promotional, advertising or merchandising use. Editorial Licensed Content (i) must be credited as indicated in the Rights and Restrictions and (ii) may be cropped, provided that the editorial integrity of such Licensed Content is not compromised, but may not otherwise be rotated, altered, changed, or tampered with, either manually or electronically, for any reason, without Charlottesville Stock Photography's express written permission.

e. "Reproduction" and "Reproduce" include any form of copying or publication of the whole or a part of any Licensed Content, whether by electronic, digital or mechanical means. Reproduction further includes the distortion or manipulation of the whole or a part of the Licensed Content (for example, by computer, electronically, digitally by an artist or by any other means), even though the resulting Licensed Content may not appear to a reasonable person to be derived from the original Licensed Content.

f. "Rights and Restrictions" means the information: (i) accompanying the Licensed Content on the Website (including all areas of the license purchase process); (ii) in the Invoice; or (iii) in any other written communication accompanying the Licensed Content.

2. GRANT OF RIGHTS

a. License. Unless stated otherwise in the Invoice, Charlottesville Stock Photography grants to Licensee a nonexclusive, nontransferable, perpetual, worldwide right to use and Reproduce the Licensed Content identified in the Invoice solely for the Permitted Use. All other rights in and to the Licensed Content, including but not limited to all copyright and other intellectual property rights relating to the Licensed Content, are retained by Charlottesville Stock Photography or the Contributor of the Licensed Content. The Invoice terms override any conflicting terms in this Agreement.

Charlottesville Stock Photography reserves the right to refuse to grant any license to any Offered Content for use in a manner inconsistent with Charlottesville Stock Photography

policies or standards, in Charlottesville Stock Photography's sole discretion.

b. Restrictions on License.

- . Licensee may not use Licensed Content in products for resale, sublicense or other distribution separately, through methods including but not limited to design templates intended for resale, web templates, electronic formats that enable users to download, distribute or share Licensed Content in peer-to-peer or file sharing arrangements, mobile applications specifically created for viewing of Licensed Content on mobile devices, or mobile-directed websites. Licensee may not assign or otherwise transfer the Licensed Content or Licensee's rights under this Agreement. Licensee may provide its customers with copies of the Licensed Content as an integral part of work product but may not permit them to use the Licensed Content separately. Separate use of the Licensed Content, including but not limited to in Reproductions, such as print or electronic compilations or screen shots, requires an additional license from Charlottesville Stock Photography and may require payment of additional license fees.
- . No more than ten (10) individuals total employed by the same entity may access the Licensed Content, irrespective of the number of individuals who access the Licensed Content at the same time. You must contact Charlottesville Stock Photography if you would like more than ten (10) individuals to access the Licensed Content, to negotiate a license extension. You may not install or use the Licensed Content in more than one location at a time or post or store the Licensed Content on a network or web server for use by more than ten (10) individuals.
- . Licensee shall provide sample copies of Reproductions containing Licensed Content to Charlottesville Stock Photography upon request and at reasonable notice. In addition, upon reasonable notice, Charlottesville Stock Photography may, at its discretion, either through its own employees or through a third party, audit Licensee's records directly related to this Agreement and use of Licensed Content in order to verify compliance with the terms of this Agreement. Where Charlottesville Stock Photography reasonably believes that Licensed Content is being used by more than the authorized number of individuals, or that Licensed Content is being used outside of the scope of the license granted under this Agreement, Licensee shall, at Charlottesville Stock Photography's request, provide a certificate of compliance signed by an officer of Licensee, in a form to be approved by Charlottesville Stock Photography.
- . Licensee may not use the Licensed Content on websites or venues designed to induce or involving the sale, license or other distribution of "on demand" products, including mugs, t-shirts, postcards and other items.
- . Licensee may not use the Licensed Content as part of a trademark, service mark, logo, or trade name.
- . Licensee may not remove any notice of copyright, trademark or other proprietary right,

including metadata included in any image, from the Licensed Content.

- . Pornographic, defamatory, libelous or otherwise unlawful use of Licensed Content is strictly prohibited whether directly or in context or juxtaposition with specific subject matter.
- . Licensee will make no Reproduction of any Licensed Content of a person well known to the general public in a manner which can be reasonably construed as the said person's endorsement of a product or service without obtaining proper permissions; nor may Licensee Reproduce any Licensed Content in a manner which can be reasonably construed as derogatory, defamatory or slanderous of any person depicted in it.
- . Licensee agrees not to use Licensed Content with sensitive topics without Charlottesville Stock Photography's express agreement. Sensitive topics include, without limitation, topics that may depict the subject matter contained in the Licensed Content in a negative or unfavorable light or subject persons to ridicule, and topics regarding all sexual issues, substance abuse, physical or mental abuse, alcohol, drugs, tobacco, AIDS, cancer or serious physical or mental ailments, or the disparagement of a person or product. Licensee must contact Charlottesville Stock Photography in connection with any proposed use of the Licensed Content with any sensitive topic and abide by Charlottesville Stock Photography's written instructions regarding such usage, which may include but are not limited to, instructions that you may not use the Licensed Content for the proposed use, or that you may use the Licensed Content for the proposed use provided you indicate that the subject is a model and being used for illustrative purposes only.
- . Licensee may not falsely represent, expressly or impliedly, that Licensee is the original creator of a work that is a stand-alone pictorial, graphic or sculptural work or other visual work that derives a substantial part of its artistic components from Licensed Content.
- . Licensee agrees to physically remove Licensed Content from its premises, computer systems and storage (electronic or physical) and, if possible, cease any future use at its own expense upon notice from Charlottesville Stock Photography, or upon Licensee's knowledge that any Licensed Content is subject to a threatened or actual claim of infringement, violation of another right, or any other claim for which Charlottesville Stock Photography may be liable herein, or if Charlottesville Stock Photography withdraws any Licensed Content from the Service for any other reason.
- . Licensee shall abide by all other restrictions on the use of the Licensed Content set forth in the Rights and Restrictions.

c. Limitations on License. Use of Licensed Content in a manner other than as expressly authorized by the Invoice and this Agreement (i) is prohibited, (ii) may constitute an infringement of the proprietary rights of Charlottesville Stock Photography or a third

party, and (iii) may result in Licensee incurring or being responsible for any damages resulting from any such use, including any damages resulting from any claims for infringement of the intellectual property or proprietary rights of Charlottesville Stock Photography or a third party. Prohibited use of Licensed Content includes use of any rights-managed Licensed Content beyond the temporal scope of the license. The rights and remedies of Charlottesville Stock Photography hereunder shall be in addition to, and not in lieu of, any other rights or remedies that Charlottesville Stock Photography may have at law or in equity. In the event you use Licensed Content in a prohibited manner, or fail to comply with any of the terms of this Agreement, Charlottesville Stock Photography may terminate this Agreement, the license granted herein, and Licensee's status as a Registered User or Subscriber of the Website, in addition to any other remedy or relief available to Charlottesville Stock Photography under equity or law. In the event that Charlottesville Stock Photography or the Website takes any action set forth in the preceding sentence, Licensee shall have no right to refund of any license fees or payments made by Licensee.

d. Clearances. Unless expressly stated to the contrary on the Invoice, the license granted hereunder does not include any underlying rights for subject matter depicted or contained in the Licensed Content, including without limitation, copyrights, trademark and/or third party property rights, moral rights, music rights, and/or the privacy and/or publicity rights of any individuals. Licensee is solely responsible for ensuring that any and all releases and clearances as may be required to use the Licensed Content are or have been obtained, including without limitation rights for any representative guild, union, professional organization, or other authorized representative. Upon Licensee's request, Charlottesville Stock Photography will (i) provide a faxed copy of an executed release submitted by the Contributor of the Licensed Content which may have certain confidential information about the subject redacted, and (ii) indicate whether the Contributor of the Licensed Content has uploaded any releases relating to such Content, but Charlottesville Stock Photography assumes no responsibility for obtaining necessary releases and will not be liable for use of any Licensed Content without a valid release when one is required, including in the event the Contributor has incorrectly indicated that such release is not required, or when any falsified release form is provided by any Contributor of Licensed Content. _

3. FEES AND PAYMENT

a. License Fees. The license fee for the Licensed Content is specified on the Invoice. License fees are set by Charlottesville Stock Photography Contributors with a minimum license fee of US \$50.00 for any image sold on the Website. Charlottesville Stock Photography will guarantee pricing for any Offered Content for thirty (30) days after such Offered Content is initially added to Licensee's shopping cart on the Website; however, since Contributors may remove Offered Content from the Website at any time, Charlottesville Stock Photography cannot guarantee continued availability of any Offered Content stored in Licensee's shopping cart for which a license has not yet been purchased.

b. Termination. If Licensee requests in writing to terminate this Agreement within thirty (30) days of the date of downloading or otherwise taking delivery of the Licensed Content, and Licensee has not used the Licensed Content in any end-state application, Charlottesville Stock Photography will terminate this Agreement and issue a check to equal to the License Fee provided. Upon termination, you must immediately cease use of the Licensed Content, destroy or delete all copies and archives of the Licensed Content, and upon request, confirm in writing to Charlottesville Stock Photography that you have complied with these requirements. Termination of this Agreement shall not prejudice Charlottesville Stock Photography's rights, defenses and limitations of liability provided under this Agreement or the Charlottesville Stock Photography Terms and Conditions, which rights, defenses and limitations of liability shall survive termination of this Agreement. Sections 1, 2c, 2d, 3b, 3e, and 4 - 7 shall survive termination of this Agreement.

c. Billing and Payment Terms: Licensee must make each payment due under this Agreement in U.S. dollars within thirty (30) days after the date Charlottesville Stock Photography sends each Invoice to Licensee. CHARLOTTESVILLE STOCK PHOTOGRAPHY RESERVES THE RIGHT, IN ITS SOLE DISCRETION, TO REVOKE THE LICENSE UPON WRITTEN NOTICE TO LICENSEE IF PAYMENT IS NOT MADE IN FULL.

d. Information Required at Invoicing. In order to purchase rights to Content displayed on the Website for sale, Licensee must provide certain information which Charlottesville Stock Photography will disclose to the Contributor of the Content to be licensed. This information includes Licensee's name, Licensee's intended use for the Licensed Content, and how the Contributor can obtain a tear sheet for the Licensed Content. No other information provided by Licensee to Charlottesville Stock Photography will be disclosed to the Contributor who provided the Licensed Content. Charlottesville Stock Photography may disclose to a Billing Service information provided by Licensee necessary or desirable to consummate the transaction (including your credit card information). Charlottesville Stock Photography may also disclose anonymous sales data in statistics provided to Contributors, site activity reports, and promotional and marketing materials including but not limited to its ticker system.

e. Prohibited Transactions. Charlottesville Stock Photography prohibits the use of Contributor, User and Subscriber contact information obtained from the Website to complete transactions outside of the Website and the use of the Website and Charlottesville Stock Photography Service to offer to license any Contributed Content outside of the Website.

4. WARRANTY AND LIMITATION OF LIABILITY

THE REPRESENTATIONS AND WARRANTIES OF CHARLOTTESVILLE STOCK PHOTOGRAPHY IN THIS AGREEMENT WILL HAVE NO FORCE OR EFFECT IF THE LICENSEE USES THE LICENSED CONTENT IN ANY MANNER OTHER THAN IN ACCORDANCE WITH THIS AGREEMENT OR THE USES SPECIFIED IN THE INVOICE OR IF LICENSEE IS OTHERWISE IN BREACH OF THIS

AGREEMENT.

a. Licensee represents and warrants that Licensee is at least eighteen years of age, or an emancipated minor, and is fully able and competent to accept, make, and/or perform the terms, conditions, obligations, affirmations, representations and warranties set forth in this Agreement. If you are under the age of eighteen, you must provide a signed consent form from your parent or guardian in order to license Offered Content from the Website.

b. Licensee should examine all Licensed Content for possible defects (whether digital or otherwise) before sending any Licensed Content for Reproduction. Charlottesville Stock Photography shall not be liable for any loss or damage suffered by Licensee or any third party, whether directly or indirectly, arising from any alleged or actual defect in any Licensed Content in any way from its Reproduction. Charlottesville Stock Photography shall not accept returns of Licensed Content after the thirty (30) day return period described in Section 3b.

c. Licensee shall maintain robust security measures on Licensee's computers to safeguard against unauthorized third-party access to the Licensed Content.

d. Charlottesville Stock Photography may categorize Offered Content on the Website by subject matter to enable users to search the Website and rate offered content by artistic quality. Charlottesville Stock Photography is not responsible for the inaccuracy or incompleteness of any search results or ratings of your Licensed Content on the Website, and makes no representations or warranties that Licensed Content will meet your requirements or expectations.

e. EXCEPT AS EXPLICITLY PROVIDED HEREIN, THE WEBSITE AND ALL CONTENT ARE PROVIDED ON AN "AS IS" BASIS. CHARLOTTESVILLE STOCK PHOTOGRAPHY DOES NOT REPRESENT OR WARRANT THAT THE MATERIALS PROVIDED HEREIN WILL BE UNINTERRUPTED OR ERROR-FREE. CHARLOTTESVILLE STOCK PHOTOGRAPHY IS NOT RESPONSIBLE FOR THE AVAILABILITY OR CONTENT OF OTHER SERVICES THAT MAY BE LINKED TO THE WEBSITE. CHARLOTTESVILLE STOCK PHOTOGRAPHY MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND WITH RESPECT TO THE WEBSITE OR LICENSED CONTENT INCLUDING ANY REPRESENTATION OR WARRANTY THAT THE USE OF THE WEBSITE WILL (I) BE TIMELY, UNINTERRUPTED OR ERROR-FREE OR OPERATE IN COMBINATION WITH ANY OTHER HARDWARE, SOFTWARE, SYSTEM OR DATA, (II) MEET YOUR REQUIREMENTS OR EXPECTATIONS, (III) BE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS. CERTAIN JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO LICENSEE.

5. INDEMNIFICATION

Licensee shall indemnify and hold Charlottesville Stock Photography, the Website, its respective officers, directors, shareholders, employees, members, and partners harmless from and against any and all suits, losses, claims, demands, liabilities, damages, costs and expenses (including reasonable legal fees and expenses) arising from or relating to (i) Licensee's use of the Licensed Content; (ii) Licensee's breach of the terms and conditions

of this Agreement or any representation, warranty or covenant made by Licensee herein; or (iii) Licensee's violation of any applicable law, statute, ordinance, regulation or any third party's rights, including but not limited to, copyright infringement, harm to a third party's trademark or other intellectual property rights, any claim of defamation, libel or slander, or violation of a third party's rights of privacy or publicity. This obligation survives indefinitely the termination and/or expiration of this Agreement.

6. APPLICABLE LAW

Any disputes arising out of or relating to this Agreement shall be resolved in accordance with the laws of the State of Virginia, without regard to its conflict of law rules. The parties hereby consent to the exclusive jurisdiction of the Albemarle County or any Virginia State court located in the County of Albemarle in all disputes arising from or relating to this Agreement or your access to or use of the Website and/or services provided by Charlottesville Stock Photography.

7. GENERAL

This Agreement (including the Charlottesville Stock Photography Terms and Conditions and Privacy Policy as modified from time to time), constitute the entire Agreement between the parties with respect to the subject matter hereof. This Agreement replaces all prior or contemporaneous understandings or agreements, written or oral, regarding the subject matter hereof. This Agreement will be binding on and will inure to the benefit of the legal representatives, successors and permitted assigns of both parties. Charlottesville Stock Photography may assign this Agreement in whole or in part at any time without your consent. This Agreement is personal to you and you may not assign this Agreement or delegate any of its obligations hereunder. No failure of either party to enforce any of its rights under this Agreement will act as a waiver of such rights. If any portion of any provision of this Agreement is found invalid or unenforceable, that provision shall be enforced to the maximum extent possible and the remaining provisions of this Agreement shall remain in full force and effect. Headings used in this Agreement are for convenience only and have no legal or contractual significance.
